Department Overview

Sat within the GRS team, the IRS team are accountable for working closely with each individual market. IDM focuses on working with the International developed markets, including Europe, UK, Canada, Australia/New Zealand, and many others. REC works with all of these markets as well as those under the Emerging Market Region and China supporting the Continuous Improvement projects. REC works closely with the numerous project teams across GRS, coordinating IRS Subject Matter Experts (SMEs) within the projects, ensuring they get the required support.

What can I achieve and what will I be accountable for whilst completing a placement at Pfizer?

Pfizer provides you with the opportunity to work with Regulatory and Project experts in the pharmaceutical industry and within the UK and across many countries globally. Through working in a busy REC team, you can look forward to developing critical project coordination and business skills and being a valued team player. One of the key skills you will gain will be communication, gained through liaising with global colleagues and external stakeholders, multi-tasking through working on a variety of projects and also leadership by owning the undergraduate programme.

Pfizer also offers a diverse environment which allows employees numerous opportunities to grow and develop. This is a great chance to be part of the bigger picture, and to assist in ensuring Pfizer maintains a
